# dotGRANTS DECOMMISSIONING

## dotGrants will be decommissioned September 2025

- All projects MUST be completed (Grant Closed) and in Grant Closed phase no later than 9-1-2025
- After September 1, 2025 dotGrants will no longer be available
- Active dotGrants projects will remain in dotGrants



# eGRANTS FOR BOA GOES LIVE

## eGrants “go live” date is November 21, 2022

- Will look and act differently
  - New application procedure that will eliminate the TA process
- Any project in TA In Progress or earlier will be moved to eGrants for subgrant processing
- Any project in TA Completed or later status will remain in dotGrants to be processed until the grant is closed
- Real Estate Tax Rebate –
  - Active in eGrants since Fall 2020

**An invitation to apply will be sent to the Sponsor via email with project specific information pulled from JACIP. The invitation to apply email will be replacing the current TA process. Example email:**

# NEW APPLICATION PROCESS

## Aviation Block Grant (ABG)

### Pennsylvania Department of Transportation

The Block Grant program provides the federal funding received by Pennsylvania from the Federal Aviation Administration (FAA) to federally eligible airport sponsors. This funding provides up to 90 percent of the cost of an eligible development project at the airport. To participate in this program, the airport sponsor develops a twelve-year plan of projects that are evaluated and programmed into the statewide balanced four-year plan.

# NEW APPLICATION PROCESS

## Aviation Capital Budget (ACB)

### Pennsylvania Department of Transportation

The Capital Budget program provides Pennsylvania general fund money to publicly sponsored, public use airports. This program can provide 50 or 75 percent of the cost of an eligible development project at an airport. Eligible sponsors work with their Legislators to create project line items in Capital Budget Bills. Then, funding release requests are received, and projects are evaluated by the State. These projects are to be on the airport's twelve-year plan.

# NEW APPLICATION PROCESS

## Aviation Development Program (ADP) [Apply](#)

### Pennsylvania Department of Transportation

The Aviation Development Program provides Pennsylvania Aviation Restricted Account funding to eligible airport sponsors. Depending on the type of project, this program can provide 50, 75, or 90 percent of the cost of an eligible development project at an airport. This program also is available to match 50 percent of the non-federal share of a Block Grant received by an airport sponsor. To participate in this program the airport sponsor develops their twelve-year plan that is evaluated and programmed into the statewide balanced four-year plan. All public-use airports are eligible to receive this funding.

# NEW APPLICATION PROCESS

**Airport Improvement Program (AIP)**

**Match**

**Pennsylvania Department of Transportation**

The AIP Match program provides Bureau of Aviation state funding for 50% of the non-federal share of a Federal Aviation Administration (FAA) federally funded project. An AIP Match grant is capped at \$600,000 per year, per airport. To participate in the program, the airport sponsor requests matching funds to the AIP grant received from the FAA. The request is processed through the eGrants system similar to other airport grants.
