

# **Developer Negotiations – Drop-In**

Many municipalities find that negotiating with developers over the cost of off-site improvement—whose need is generated, at least in part, by their proposed development—can be a very effective means of implementing improvements to the transportation system and other infrastructure. These negotiations are acceptable if conducted in accordance with the MPC and current case law. #### Active transportation Workshop, September 28, 2023, 8 a.m. to Noon

The Active Transportation training course will discuss the latest research and guidelines for nonmotorized transportation modes. Many communities in Pennsylvania are encouraging more active transportation (walking, cycling, etc.) to enhance their community and foster healthy lifestyles. Corresponding to this encouragement of active transportation, communities are looking to develop active transportation plans to help create more facilities such as bicycle paths, sidewalks, trails, greenways, etc. This course will examine the safety and standards for these facilities, as well as how to develop an active transportation plan. The course will also highlight successful examples of local plans, practices, and policies in Pennsylvania. Intended Audience: This course is intended for local officials responsible for the planning, design, and implementation of bicycle, greenways, trails, and related facilities. This includes municipal managers, elected officials, public works directors, roadmasters, and code enforcement officers.

# **Discretionary Grants Spotlight**

#### **Currently Available Pennsylvania Discretionary Grants**

#### **Reconnecting Communities and Neighborhoods Grant Program**

The Reconnecting Communities Pilot (RCP) Program has been combined with the new Neighborhood Access and Equity (NAE) Program to form Reconnecting Communities and Neighborhoods (RCN) Grant Program. The RCN grant program advances community-centered transportation connection projects with a priority for projects that 1) benefit disadvantaged communities; 2) improve access to daily needs such as jobs, education, healthcare, food, nature, and recreation and 3) foster equitable development and restoration.

Both the RCP and NAE programs provide technical assistance and funding. RCP focuses on planning and capital construction to address infrastructure barriers, restore community connectivity and improve people's lives. NAE concentrates on improving walkability, safety and affordable transportation access through community connectivity; mitigating or remediating negative impacts on the human or natural environment and assisting economically disadvantaged or underserved communities with planning and capacity building activities.

PennDOT will consider providing support for regionally supported grant proposals as applicable. PennDOT support may include offering data and subject matter expertise as available.

- The deadline for requesting PennDOT support is September 14, 2023.
- The deadline to apply for this program is September 28, 2023, 11:59 p.m. EST.

#### **Rural and Tribal Assistance Pilot Program**

The <u>Rural and Tribal Assistance Pilot Program</u> provides grants to fund financial, technical and legal assistance to states and rural and tribal communities. The grants are intended to increase organizational capacity in communities that may not have resources available to evaluate and develop projects that qualify for federal funding and financing programs. Grants are awarded for either the hiring of staff or the procurement of expert firms to provide financial, technical and legal assistance. This program provides opportunities for rural and tribal communities to grow capacity, either internally or through a third-party, and to prepare and develop projects which are or will be eligible for discretionary grant funding.

PennDOT will consider providing support for grant applications on a case-by-case basis.

- The deadline window for requesting PennDOT support begins July 31, 2023, and ends September 13, 2023.
- The application window to apply for this program is August 14 to September 27, 2023.

#### Multimodal Project Discretionary Grant – INFRA, Mega, and Rural Grant Programs

The <u>Multimodal Project Discretionary Grant</u> (MPDG) is soliciting applications for three funding opportunities: 1) Nationally Significant Multimodal Freight and Highways (INFRA grant), 2) National Infrastructure Project Assistance (Mega grant) and 3) Rural Surface Transportation (Rural grant). This program allows applicants to apply for one, two or all three funding opportunities by submitting a single

application. MPDG funds for the INFRA, Mega and Rural grants provide financial assistance to highway and bridge, intercity passenger rail, railway-highway grade and separation, wildlife crossing, public transportation, marine highway and freight and multimodal projects, or groups of such projects of national or regional significance, as well as projects improving and expanding the surface transportation infrastructure in rural areas.

PennDOT will consider providing support for regionally supported grant proposals as applicable and may provide data and subject matter expertise as available. PennDOT recognizes the potential this program has to significantly help communities and individuals and will consider how to assist or collaborate with applicants to advance and strengthen competitive proposals. Collaboration with other state agencies where there may be an interest is also possible.

- The deadline for requesting PennDOT support is August 7, 2023.
- The deadline to apply for this program is August 21, 2023, 11:59 p.m. EST.

#### Promoting Resilient Operations for Transformative, Efficient and Cost-Saving Transportation

The Promoting Resilient Operations for Transformative, Efficient and Cost-Saving Transportation (PROTECT) program provides funding to build community infrastructure resilience in the face of extreme weather and natural disasters supporting the continued operation or rapid recovery of crucial local, regional or national surface transportation facilities, including highways, public transportation, ports and intercity passenger rail. Projects in the PROTECT program also have the potential to demonstrate innovation and best practices that state and local governments can consider replicating.

PennDOT will consider providing support for regionally supported grant proposals as applicable and may provide data and subject matter expertise as available.

- The deadline for requesting PennDOT support is August 4, 2023.
- The deadline to apply for this program is August 18, 2023, 11:59 p.m. EST.

#### Pittston Pair Bridge Bundle and Investing in America

In every state, across thousands of communities, investments in infrastructure projects are improving safety, creating jobs, and growing the economy. See what is getting built near your community at <a href="Investing in America">Investing in America</a>. This website provides an interactive map that illustrates the impact of these record-breaking levels of public and private investment across states and territories under the Biden Administration.

The grants are part of President Biden's Investing in America agenda that is growing the American economy from the bottom up and middle-out. During June 2023, the Biden Administration announced funding for 162 community-led infrastructure projects as a part of the Investing in America agenda. This year, the Rebuilding American Infrastructure with Sustainability and Equity (RAISE) program will fund projects in all 50 states, the District of Columbia, and two territories with more than \$2.2 billion.

The RAISE grant program, expanded under the Bipartisan Infrastructure Law, supports communities of all sizes, with half of the 2023 funding going to rural areas and the other half to urban areas.

One such program in Pennsylvania is the Pittston Pair Bridge Bundle which received a \$19 million RAISE grant award. This project will fund the design, right-of-way, utilities, and construction for the replacement of the Fort Jenkin Bridge and the Water Street Bridge, including on-street bicycle and pedestrian infrastructure improvements in Pittston, Pennsylvania. The project will also involve the modernization of seven adjacent intersections to include ADA accommodations, traffic signal reflectivity, retiming, pedestrian interval considerations at approach intersections and dedicated turning lanes where warranted.

# **New Guide for Bipartisan Infrastructure Law Grant Applications**

PennDOT has added a <u>Bipartisan Infrastructure Law (BIL)</u> guide for grant applications to the website dedicated to the Infrastructure Investment and Jobs Act (IIJA), also referred to as the BIL, and specifically the federal discretionary programs. Also, included are Grant Alerts that provide background on these opportunities including eligibility, application deadlines, and federal and Department of Transportation (USDOT) resources and guides to assist in applying for the specific programs.

#### **New USDOT Discretionary Grant Resources**

The U.S. Department of Transportation (USDOT) has developed a discretionary grant preparation checklist for fiscal year 2023 to help applicants prepare and chart a strategic pathway to apply for infrastructure investments. More than \$32 billion is available to the USDOT this fiscal year to provide competitive grant funding to local governments, metropolitan planning organizations, transit agencies, Tribal governments, U.S. Territories and state departments of transportation. The USDOT has published a list of anticipated dates for upcoming Notices of Funding Opportunity (NOFOs) for key programs within the Bipartisan Infrastructure Law (BIL) and the Inflation Reduction Act (IRA), as well as adjacent programs that support BIL and IRA objectives. This list is not comprehensive, and the agency will periodically update it with additional programs and revised dates as appropriate.
