I. Introduction

For the past several years, the Pennsylvania Department of Transportation (PennDOT), the Federal Highway Administration (FHWA), the United States Army Corps of Engineers (USACE) (Baltimore, Philadelphia, and Pittsburgh Branches), the Advisory Council on Historic Preservation (ACHP) and the Pennsylvania State Historic Preservation Office (SHPO) have been negotiating a new Programmatic Agreement to cover highway projects that receive federal funding from FHWA or for projects that have state funding but may also need a permit from the USACE. This new Delegation PA was completed and signed by all parties at the end of 2022 except the ACHP, and was fully executed February 17, 2023. Therefore, since PennDOT was still operating under the *Amended Programmatic Agreement Among the Federal Highway Administration the Advisory Council on Historic Preservation, the Pennsylvania State Historic Preservation Officer and the Pennsylvania Department of Transportation Regarding Implementation of the Federal Aid Highway Program in Pennsylvania (Amended PA)* through the end of 2022, this annual report pertains only to projects funded by FHWA within PennDOT's Highway Administration Deputate.

The period covered in this annual review is January 1 and December 31, 2022 and provides summary statistics on: projects exempted from further Section 106 review; effect findings (i.e., no effects, no adverse effects, and adverse effects); information on SHPO objections to effects determinations; an update on PennDOT Cultural Resource Professionals (CRPs) and District Designees (DDs) staffing and training to maintain their delegation to review projects under the Amended PA; and finally, a few notable success stories.

II. Summary of Projects Reviewed under the PA

The heart of this document comes from Section X.D of the Amended PA, which states: "PennDOT will prepare an annual report on the activities carried out under this Amended PA. The report will include a list of projects and findings made by PennDOT. The report may also identify issues and make recommendations for improving the implementation of this Amended PA. PennDOT will submit the report to the signatories of this Amended PA, within 60 days of the start of the calendar year. The report will serve as the basis for an annual review of this Amended PA."

This section provides a statistical summary of projects reviewed by PennDOT Cultural Resource Professionals (CRPs), as well as District Designees (DDs)—District Designees are PennDOT environmental staff in the Engineering Districts who have completed Section 106 training—for exempted projects and describes SHPO disagreements with determinations of eligibility and effect made by PennDOT. The data

in the tables below are derived from PennDOT’s online cultural resources public consultation website PATH (Pennsylvania Transportation and Heritage) which can be found at <https://path.penndot.pa.gov/>. The full project details for the exempted projects can be found in **Appendix A**, while the details of the projects where PennDOT made effect findings is found in **Appendix B**.

a. Exemptions

Appendix C of the Amended PA contains a list of project activities that may be exempted from further Section 106 review provided that the activities meet certain conditions. The activities on the list, with the conditions imposed, should have no potential to effect historic properties. Appendix C of the Amended PA is divided into two sections, Level 1 activities and Level 2 activities. Level 1 activities may be exempted by either DDs or CRPs, while Level 2 activities can only be exempted by CRPs.

Between January 1st and December 31st, 2022, PennDOT exempted 293 federally funded projects from further Section 106 review. District Designees exempting 63 projects while CRPs exempting 145.

b. Non-Exempt Projects

In addition to the 293 exempted federal highway-aid projects, PennDOT also made 151 effect determinations. This includes: 117 findings of “no effect” (78%), 23 findings of “no adverse effect” (15%), and 11 findings of “adverse effects” (7%). These numbers are similar to the past several years of project undertakings and effect findings among the Engineering Districts and for PennDOT’s Cultural Resources program as a whole. The below table categorizes the effect findings by PennDOT Engineering Districts. A full listing of project findings can be found in **Appendix B**.

III. Disagreements/Objections by the SHPO on Eligibility and Effects

A large component of PennDOT’s project delivery program and consultation under Section 106 relies on the inherent trust placed on it, and built over many years, by the SHPO and FHWA to submit projects without review and/or concurrence. As spelled out in the Amended PA, PennDOT is only required to consult with the SHPO on findings of “no adverse effect” under certain conditions, and all “adverse effect” findings.

PennDOT's CRPs may also consult with SHPO and seek concurrence outside of these scenarios at their discretion. Typically, this may include concurrence on the area of potential effect, level of identification, mitigation, and other consultation as part of the Section 106 undertaking.

- District 5-0, Berks Co., SR 0419-02B, MPMS# 91908, SHPO Review#: 2019PR03588: PennDOT determined the Braun Mill (Resource# 1989RE00172) eligible for listing in the National Register of Historic Places under Criterion A for industry and Criterion C for agriculture. At the time the mill was originally determined eligible (in 1989), a boundary was not established for the resource. PennDOT proposed a boundary and the SHPO disagreed with the proposed boundary. Consultation on the boundary is ongoing as of the drafting of this report.

PennDOT also determined that the segment of the Union Canal (Resource# 2022RE00188) within the APE did not contribute to the eligibility of the overall resource. SHPO disagreed stating that "the Union Canal (S.R. 0419 Section) retains sufficient integrity to convey this significance and association to the larger resource. This section of the canal retains evidence of the canal prism, berms, and towpath and retains its lock tender's house, which enhances integrity of association, feeling, setting, workmanship, and location." Consultation is continuing on the eligibility of this resource as well.

- District 8-0, Lancaster Co., SR 0741-025, MPMS# 100543, SHPO Review#: 2022PR00771: PennDOT determined that the farm at 1996 Millersville Road (Resource# 2022RE09012) did not meet the criteria for listing in the National Register of Historic Places. However, SHPO disagreed with PennDOT's determination, stating it is their opinion that the farm is "eligible for listing in the NRHP under Criterion A in the area of Agriculture as a farm meeting the property registration and census data requirements for the 1920 to 1960 "Livestock, Tobacco, Truck Farming, and Poultry" period of the Lancaster Plain region" and "the property may also be eligible under Criterion C (Architecture) for the 1851 Pennsylvania bank barn and house. The barn has a machine entrance in one gable end and a forebay in the other gable end - a feature not common and reflects the specific function and use of the original farming operations. As for the house, it is a well-intact example of a Pennsylvania German continental farmhouse with the double porches with good integrity." Consultation is continuing on the eligibility of this resource.
- District 9-0, Somerset Co., SR 7220-712, MPMS# 72477, SHPO Review# 2020PR00717. PennDOT determined the Philip Reitz House (2022RE07004)

is eligible for listing in the National Register of Historic Places, with which the SHPO concurred. However, the SHPO disagreed on the boundary determination. PennDOT resolved this objection by drawing a new boundary that “includes the barn foundation as requested by the SHPO, as well as the remainder of much of the yard areas associated with the property. The property continues to exclude the mid-twentieth century utility buildings at the northwest corner of the property, and also excludes the densely forested areas on the eastern and northern sides of the property.” SHPO concurred with this newly delineated boundary for the resource.

- District 12-0, Westmoreland Co., SR 0981-V20, MPMS# 108010, SHPO Review# 2021PR07033. PennDOT determined that the Brechbill-Fenton Farm (Resource# 2022RE00688) did not meet the eligibility requirements for listing in the National Register of Historic Places. However, SHPO disagreed stating that the resource “is eligible under Criterion A in the Area of Agriculture as a representative example of a southwestern Pennsylvania/Allegheny Mountain Part-Time and General Farming Region farm. The property illustrates the trends during the Dairy and Poultry Production for Local and Regional Markets, 1920-1960. The complex retains a built environment that shows dairy and poultry production for local and regional markets and retains sufficient integrity to convey the agricultural production trends.” PennDOT provided SHPO with supplemental information regarding the National Register eligibility and agreed with SHPO’s opinion.

IV. PennDOT Staff Updates

There are no new staffing updates for this annual report. PennDOT retains a full complement of 12 Cultural Resources Professionals (six architectural historians and six archaeologists), two supervisors (one each for the archaeologists and architectural historians), a historic bridge program manager and a section chief. Contact information for the CRPs and map of their respective Engineering Districts is included as **Appendix C**.

V. Training and Delegation under the PA

PennDOT, FHWA, and SHPO held a one-day joint meeting in September 2022 at Monocacy Park in Bethlehem, PA. The meeting met the requirements of Appendix B of the Amended PA for annual CRP refresher training. PennDOT kept this meeting to agency personnel only; therefore, Delegated CRP consultants who were seeking to retain their delegation were offered an online webinar to fulfill the refresher training

requirements on November 3rd, 2022. PennDOT also offered refresher training to District Designees operating under the Amended PA on October 25th. In addition to these refresher trainings, PennDOT also offered training for newly delegated District Designees on November 9th, 2022. A list of the PennDOT's delegated consultants is found in **Appendix D** and District Designees is in **Appendix E**.

VI. Successful Consultation

- District 5-0: Schuylkill County, Mount Carbon Bowstring Adaptive Reuse Project. PennDOT Highway Administration and Multimodal Deputates partnered with the Schuylkill County Municipal Authority (SMCA) and Schuylkill River Greenways Association (SRGA) to rehabilitate and relocate an 1894 bowstring truss bridge to a trail four miles north of its current location. The bridge was owned by SCMA, carrying an active water line over the Schuylkill River. Lockhart Ironworks dismantled the bridge in August of 2022 and transported it to their Ohio shop where it is currently under rehabilitation. PennDOT anticipates reassembling the bridge on a SRGA trail adjacent to SR 61 north of St. Clair in the Spring of 2023. PennDOT Multimodal funds, along with mitigation funds from the loss of two other historic bridges, paid for the project.



- District 6-0: Delaware County, Bryn Mawr Avenue Bridges Rehabilitation Project. The project included the rehabilitation of three bridges: the ca. 1905 culvert over a tributary to Meadowbrook Run is a single-span brick arch culvert with two decorative brick parapets; the ca. 1905 bridge over Meadowbrook Run is a concrete encased steel beam bridge with decorative arched brick fascias and parapets and is listed on the National Register of Historic Places; and the ca. 1905 culvert over Doom Run is a single-span brick arch culvert with one decorative parapet. The three Bryn Mawr Avenue bridges are important as a grouping that form a distinctive landscape characteristic along the road. All three bridges were gifted to Radnor Township in 1905 by George W. C. Drexel, whose estate was nearby. The bridges share decorative details including similar ornamental brick and stone parapets. The striking design and materials are reminiscent of the design vocabulary introduced by architect Frank Furness. All three bridges had deteriorated significantly and were in poor condition, requiring rehabilitation to extend their service life. This project successfully preserved a collection of historic bridges while upgrading the bridges to serve modern transportation needs and the community. Ensuring that the bridge rehabilitation



project maintained the historic character of the three Bryn Mawr Avenue Bridges by meeting *The Secretary of the Interior's Standards for the Treatment of Historic Properties* was a critical design requirement. This was accomplished by good engineering and design that respected the original character of the bridges.

- PennDOT District 11-0: Allegheny County, Fern Hollow Bridge (Forbes Avenue over Fern Hollow). On the morning of January 28, 2022, the bridge carrying Forbes Avenue through Frick Park unexpectedly collapsed into the Fern Hollow valley. Emergency declarations issued by Governor Wolf and President Biden not only procured immediate funding for replacing the bridge but also allowed the use of expedited consultation procedures. PennDOT CRPs worked closely with the PA SHPO: first, to consult on the immediate clean up needs of the site and second, on the proposed replacement structure. Being a design-build project, PennDOT, SHPO and Section 106 Consulting Parties cooperatively made quick decisions to avoid an adverse effect to three NRHP listed and eligible properties: Frick Park, Briar Cliff Historic District and Waverly Presbyterian Church.



- PennDOT Program-wide: New Deal Resources Initiative.
This year, PennDOT worked with the SHPO to complete the New Deal Resources work plan item. The group created National Register evaluation guidance for Civilian Conservation Corps (CCC), Public Works Administration (PWA), and Works Progress Administration (WPA) Isolated Road-Related Features dating between 1933 and 1942. PennDOT CRPs provided examples of potential resources in their Districts. The Department organized three site visits of resources in Eastern Pennsylvania; the remainder of the resources were reviewed via videoconference. Eleven resources, many of which have several contributing elements, were evaluated or re-evaluated with the new guidance. The final work product provides a reliable and consistent framework PennDOT will use to determine National Register-eligibility for New Deal resources, improving predictability in project delivery.



- PennDOT Program-wide: Historic Agricultural Districts.
This year PennDOT provided continued assistance to the SHPO in an effort to provide guidance for the evaluation of historic agricultural districts. The effort included field views of several agricultural valleys/potential districts and review

and comment on related documentation/assessments as well as the guidelines for assessing the potential for historic agricultural districts.

VII. Recommendations

As evidenced above, the SHPO raised few concerns/made few objections to findings in 2022. The few objections/disagreements that did occur were either resolved quickly, or PennDOT is actively working to resolve. PennDOT and the FHWA did take one project (MPMS# 110311) to the Keeper of the National Register of Historic Places (Keeper) in 2022. The disagreement, which occurred prior to 2022, related to the boundary of the Avondale Historic District (SHPO Key No. 116441); PennDOT's contention was/is that the boundary needs to be changed to exclude an area along SR 41 that has suffered a number of modern intrusions and has lost integrity. The agencies and the SHPO mutually agreed that guidance on this issue from the Keeper would benefit the project and similar situations in the future. The coordination with the Keeper's office is on-going at the time of this report.

Additionally, the SHPO raised concerns with two projects in, or related to, construction. The first project, the Seventh Street Bridge over Chester Creek, resulted in unanticipated impacts to the 7th Street Family Theater site (36DE0122), the remains of a 19th-20th century theater. Design changes during construction resulted in an adverse effect to the site. There were several misunderstandings and misinterpretations made by the bridge owner's design consultant, the contractor's design consultant, the contractor, and the bridge's owner's construction inspection and management consultant that resulted in the partial demolition of a masonry wall with brick arch. In consultation with the SHPO, the team agreed to mitigation for the adverse effect; this included partial reconstruction of the brick arch portion that was removed and reconstruction of the masonry wall between the masonry wall with brick arches and the new bridge abutment.

Another project where the SHPO voiced concerns related to work in construction was the SR 405 bridge over Glade Run in Lycoming County (MPMS #6261). The project is located within the Muncy Historic District. In addition to context sensitive design on the new bridge, the mitigation included use of a "darker or muted color stone for rip rap needed to stabilize the stream bank." During construction part of the rip rap was covered with a brown mortar. While the SHPO expressed concerns that the contractor didn't pay attention to the special provisions, in actuality the contractor followed the special provisions. The CRP was not aware that the contract included provisions for mortar around two drainage pipes and was subsequently informed that this is a common practice. The lesson learned from this project is that the design team needs to coordinate special provisions, or changes to special provisions, with the environmental unit and CRPs.

Both projects demonstrate the importance of communication, including communication after the Section 106 process is concluded and the project is refined in final design and/or when changes are proposed during construction. A best practice that can be implemented from these examples is to require coordination/consultation with the CRPs for any derivation from the special provisions written at the time of Section 106 consultation or the creation of any additional special provisions during final design where there are historic properties or archaeological sites present. Fortunately, these are isolated events and the majority of projects do not result in concerns.

PennDOT, FHWA, and the SHPO held on a meeting on January 20th, 2023 to discuss the results of the annual report and determine if FHWA or SHPO would require monitoring of the program through an audit of PennDOT's Section 106 exemptions or eligibility and effects determinations. SHPO recommended that monitoring of the program was not needed for 2022 as consultation between the agencies has been very effective. The SHPO felt, and the FHWA agreed, that the above-referenced issues/short-comings are isolated and not reflecting a systemic problem; they do, however, offer an opportunity to implement measures statewide to prevent that from occurring.

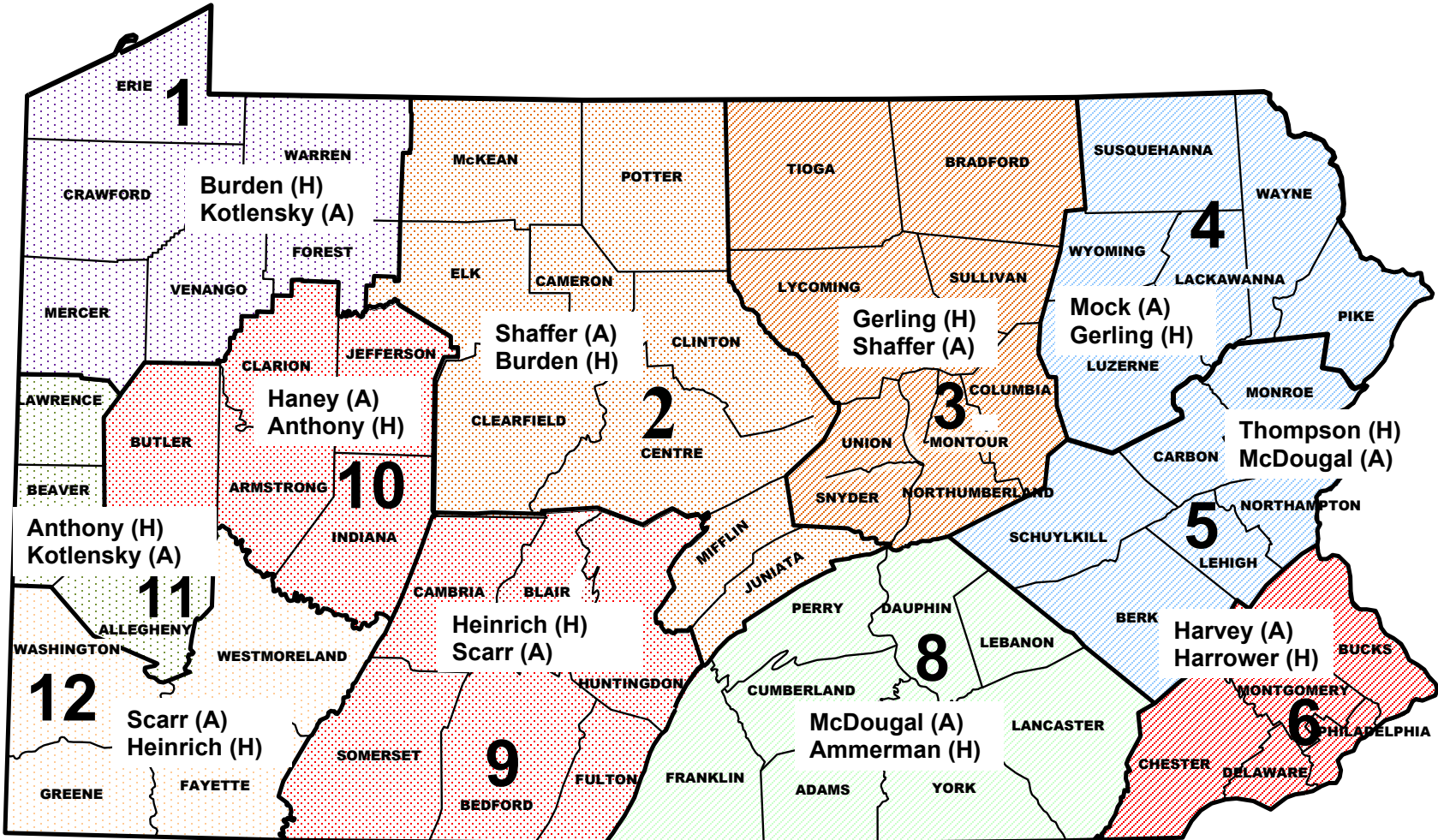
