

Shapiro Administration Announces \$28 Million in Funding Opportunities Through Transportation Alternatives Set-Aside Program

Eligible projects include Safe Routes to School

The Pennsylvania Department of Transportation (PennDOT) announced that the application round for the <u>2023 Transportation Alternatives Set-Aside (TASA)</u> of the Federal Highway Administration's (FHWA) Surface Transportation Block Grant Program will open to project sponsors May 30, 2023. Approximately \$28 million in statewide funds will be made available.

The TASA provides funding for projects and activities defined as transportation alternatives, including on- and off-road pedestrian and bicycle facilities, infrastructure projects for improving non-driver access to public transportation and enhanced mobility, community improvement activities, and environmental mitigation, and trails that serve a transportation purpose. Eligible project sponsors include local, county, and tribal governments, transit agencies, schools, school districts, nonprofits, and small Metropolitan Planning Organizations (MPOs).

Additionally, the TASA includes Safe Routes to School (SRTS) projects, which can include sidewalk/ADA ramp improvements, bike safety lessons, and bike rodeos.

"Projects like the ones TASA supports are crucial to improving mobility in our communities," said **PennDOT Secretary Mike Carroll**. "The TASA program can provide critical aid our communities to support these important projects in communities across the Commonwealth."

Additional projects eligible for TASA funding may include bicycle and pedestrian facilities, conversion of abandoned railway corridors to trails, stormwater management, and construction of turnouts, overlooks and viewing areas. Eligible projects are not required to be located on PennDOT roadways and may be located within local rights-of-way.

Sponsors may submit draft applications through July 17, 2023, for District review. After review, final applications may be submitted until September 15, 2023. Selections from participating large MPOs will be due December 1, 2023. The statewide project selection committee will meet in January 2024 to recommend projects for statewide Transportation Alternatives Set-Aside funds. Approximately \$28 million in statewide funds will be made available. Additional funds may be made available through participating MPO regional funds.

Charging and Fueling Infrastructure Discretionary Grant Opportunity (CFI Program)

The <u>CFI program</u> provides alternative fuels infrastructure grants through two separate grant categories:

- 1) Community Charging and Fueling and
- 2) Alternative Fuel Corridor.

PennDOT will consider providing support for regional grant proposals as applicable. PennDOT support may include offering data and subject matter expertise as available.

PennDOT recognizes the potential this program has to significantly help communities and individuals and will consider how the Department might assist or collaborate with applicants to advance and strengthen competitive proposals. PennDOT will also collaborate with other state agencies where there may be an interest in this program.

The deadline for requesting PennDOT support was May 30, 2023.

The deadline to apply for this program is Tuesday, June 13, 2023, 11:59 p.m. EST.



Promoting Resilient Operations for Transformative, Efficient and Cost-Saving Transportation (PROTECT)

The <u>Promoting Resilient Operations for Transformative, Efficient and Cost-Saving Transportation (PROTECT)</u> program is now open! PROTECT funding can be used to build community infrastructure resilience in the face of extreme weather and natural disasters. Information on this, and other opportunities, can be found on the <u>Infrastructure Investment and Jobs Act (IIJA)</u> <u>website</u>. Please review this program to determine if it is an opportunity that would benefit your community. Also, return to <u>PennDOT's IIJA webpage</u> often, as additional information on federal opportunities will be added as it becomes available.

PennDOT will consider providing support for regionally supported PROTECT grant proposals as applicable and may include providing data and subject matter expertise as available.

The deadline for requesting PennDOT support is August 4, 2023.

The deadline to apply is August 18, 2023.

Wildlife Crossing Program



The <u>Wildlife Crossings Pilot Program (WCPP)</u> is a competitive grant program with the goal of reducing Wildlife Vehicle Collisions (WVCs) while improving habitat connectivity for terrestrial and aquatic species.

Applications must be submitted electronically through Grants.gov no later than 11:59 p.m., (EDT), on August 1, 2023.

The Safe Streets and Roads for All FY23

The <u>fiscal year (FY) 2023 Notice of Funding Opportunity (NOFO)</u> for Safe Streets and Roads for All grants is <u>live on Grants.gov</u> and open for applications.

PROTECT Discretionary Grant Program

The purpose of the PROTECT Formula and Discretionary Grant programs is to plan for and strengthen surface transportation to be more resilient to natural hazards, including climate change, sea level rise, flooding, extreme weather events, and other natural disasters through formula and competitive discretionary grants. FHWA issued guidance for the formula portion of PROTECT in July 2022. This NOFO is for the discretionary portion of PROTECT. It will result in the distribution of up to \$848 million for the PROTECT Discretionary Grant Program through a competitive discretionary grant process. FHWA intends to hold future solicitations for funding available in FY 2024-2026.

There are four categories of funding under the PROTECT Discretionary Grant Program. One category is for Planning Grants. The other three categories are for Resilience Improvements, Community Resilience and Evacuation Routes, and At-Risk Coastal Infrastructure projects. Throughout the NOFO these are collectively referred to as Resilience Grants.

New USDOT Discretionary Grant Resources

The U.S. Department of Transportation (USDOT) has developed a discretionary grant preparation checklist for fiscal year 2023 to help applicants prepare and chart a strategic pathway to apply for infrastructure investments. More than \$32 billion is available to the USDOT this fiscal year to provide competitive grant funding to local governments, metropolitan planning organizations, transit agencies, Tribal governments, U.S. Territories and state departments of transportation. The USDOT has published a list of anticipated dates for upcoming Notices of Funding Opportunity (NOFOs) for key programs within the Bipartisan Infrastructure Law (BIL) and the Inflation Reduction Act (IRA), as well as adjacent programs that support BIL and IRA objectives. This list is not comprehensive, and the agency will periodically update it with additional programs and revised dates as appropriate.
