


PARTNERSHIP 81 PROJECT





PROJECT PURPOSE

- Address needed safety and mobility improvements along a section of I-81 in Luzerne County
- Alleviate peak travel congestion through corridor
- Utilize innovative P3 delivery to accelerate schedule and realize cost savings



PROJECT IMPROVEMENTS

- Reconstruction and widening of I-81 to three lanes in each direction
- Elimination of a left-hand exit on I-81
- Replacement of poor condition bridges
- Redesign of other intersections immediately off I-81







RBR Bridges Constructed by Year






COMPRESSED NATURAL GAS (CNG) FUELING STATIONS




