Local Government Safety Seminar Promotes Goal: Toward Zero Deaths

In collaboration with PennDOT and the Federal Highway Administration (FHWA), the State Transportation Innovation Council (STIC) recently hosted its **Local Government Safety Seminar** at the Farm Show Complex in Harrisburg. In 2016, PennDOT was awarded STIC Incentive funds dedicated to help make this event a reality. The event was designed to encourage local government officials to learn about a variety of subjects including roadway safety planning, how to install cost-effective countermeasures to reduce crashes, and how to find funding for roadway safety projects. Attendance was impressive, with 110 in-person attendees and more than 100 online participants at over 80 locations representing local governments and planning organizations from around the state.

Presentations were provided by experts from PennDOT, FHWA, the National Highway Traffic Safety Administration, and a wide variety of planning and advocacy organizations, as well as local government representatives who shared their success stories on improving roadway safety in their communities.

Among the success stories, **Jane Billings, Borough Manager**, discussed **Swarthmore Borough's** decision to install a roundabout and how safety has improved tremendously at the intersection. In addition to it being safer for vehicles, the roundabout is able to provide shorter crossing paths and increase protection for pedestrians from vehicles passing through the intersection.

Several STIC members also attended the showcase their support of the safety initiative. For example, **William Clark** from the **York County Planning Commission** was in attendance, and presented on the benefits of creating a road safety plan.

Connecting with Local Governments

Secretary of Transportation Leslie Richards delivered a keynote presentation on the PennDOT Connects program, designed to foster collaboration between PennDOT and local governments to ensure that local concerns and needs are considered in PennDOT projects.

Example of Innovative Countermeasures

One innovation countermeasure discussed was High Friction Surface Treatment (HFST). HFST is applied to areas that have higher rates of roadway departures and crashes. HFST uses high-quality, wear-resistant aggregates, like bauxite, to provide increased friction on pavements. This helps keep vehicles in their lane on slippery pavement, limits skidding and makes it easier for drivers to stop in areas where vehicles exhibit a higher propensity for crashes. The result is a durable, long-lasting innovation that leads to safer roadways for the public.
